a) 2024/2434/FPA - Land West of Moss End Business Village

Proposed erection of new storage and distribution warehouse, together with office accommodation, associated works and landscapting (Class b8)

Following extensive discussion it was agreed that the Parish Council would object to this application on the following points:

Green field, traffic, landscape, loss of agricultural land, environmental impact, social and economic impact and the fact there are alternative sites.

2024/2185/FPA - Greenways, Gatebeck

Two storey side extension, front porch extension, new access track, addition of dormers to front of the property, stable block to rear, landscaping to the side of the property to allow for dedicated access to property

It was agreed that the Parish Council had no objection to this application providing the drainage was adequate and would not cause flooding problems in the future.
